## How do I apply for PQS PAS91 Approval?

You need to register with the PQS portal, purchase the relevant PAS91 Package, answer questions within the PQS portal and submit to the PQS team for review.

## What is PAS91?

Originally developed by BSI, PAS91 is a publicly available specification (PAS) that sets out the content, format and use of questions that are widely applicable to pre-qualification for tendering. Organisations use the Silver or Gold Certification to help fulfil the questions of PQQs/Tenders for the specialist areas of quality, environment and equality. Your clients may have other pre-qualification requirements.

## Does PQS recognise an existing ISO certification to satisfy the quality or environmental modules?

We recognise UKAS Accredited ISO certificates for quality and environmental modules. Once verified, you will not need to complete the remainder of the quality and/or environmental module.

## How long is PAS91 Approval valid?

PAS91 approval is valid for 12 months from the date all modules are passed. If you have an existing certificate (e.g. ISO9001) that expires within 12 months, you will be permitted to upload the new certificate at no extra cost.

## What happens at renewal?

You will be reminded of renewal and have the choice to renew with the PQS Pre-Qualification-Scheme or let your approval expire. You are not tied to PQS and are free to make a value judgement during the renewal process. At renewal, you simply purchase another assessment for the normal advertised fee.

## How long do I have to submit?

Once purchased, we would expect you to submit the assessment within 6 months. You can submit each module individually when ready.

## How quickly can my submission be assessed?

Once you submit the assessment, an assessor will be assigned and will typically undertake a review within 4 days. We also have a 24 and 48 hour fast track option.

## Is there a pass or fail?




If you do not fulfil the criteria, the assessor will request further information from you. You will not be converted to FAIL if the assessment is returned to you more than once or you are slow to re-submit the assessment to us. You will not pay any additional fees if the assessment is returned to you for further information.

## Are there any hidden fees?

No. You pay for an annual assessment that is valid from the date you pass the assessment. There are no membership fees.
